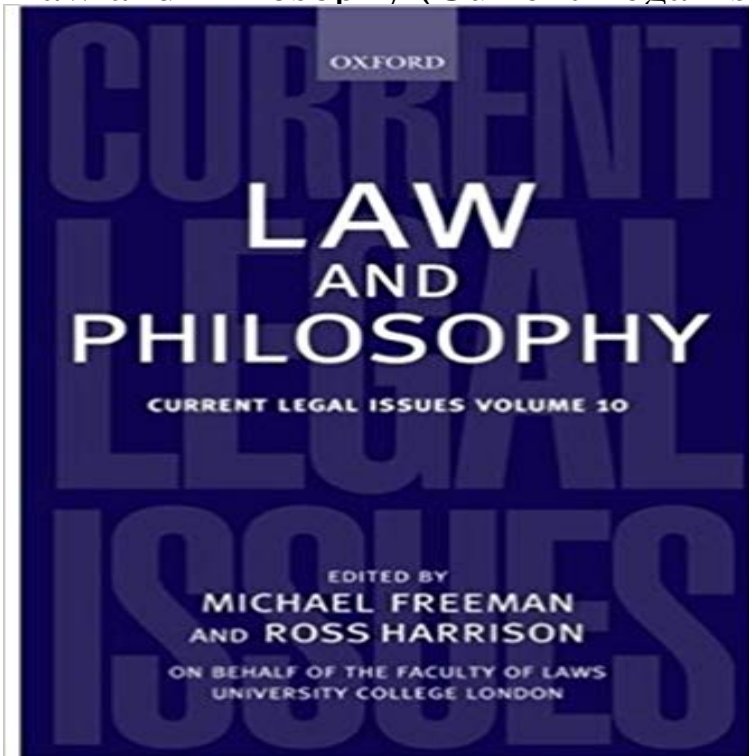


Law and Philosophy (Current Legal Issues)
