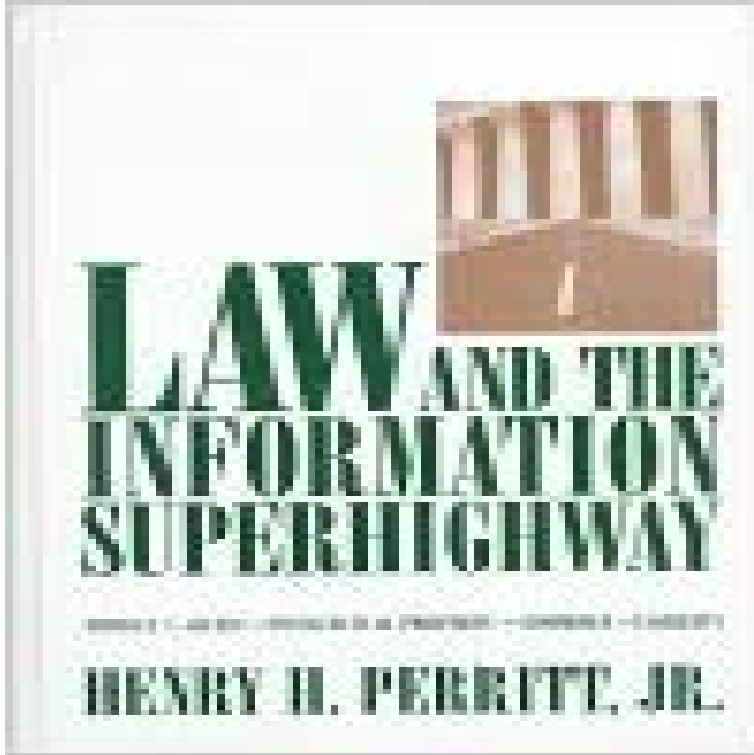


Law and the Information Superhighway: Privacy, Access, Intellectual Property, Commerce, Liability (Business Practice Library)
