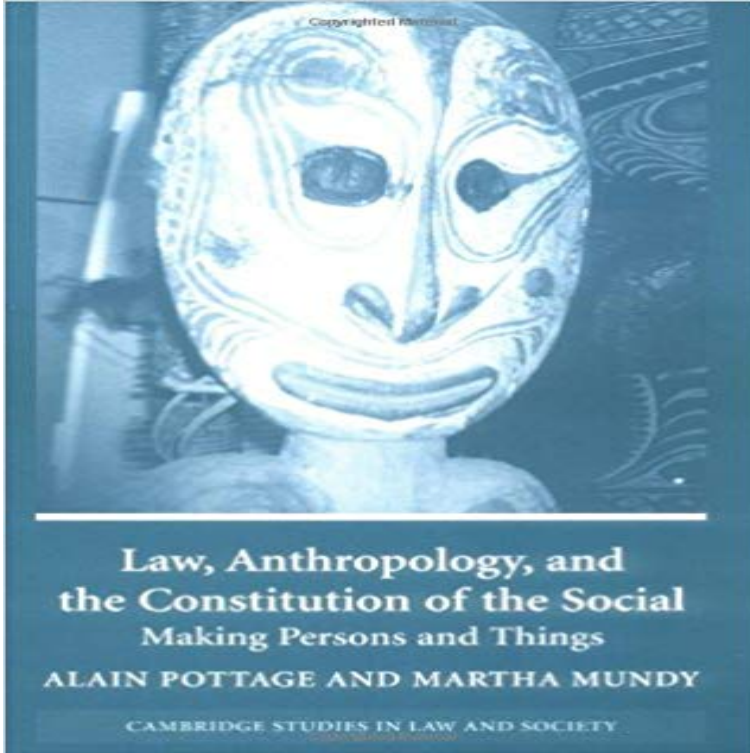


# Law, Anthropology, and the Constitution of the Social: Making Persons and Things (Cambridge Studies in Law and Society)
