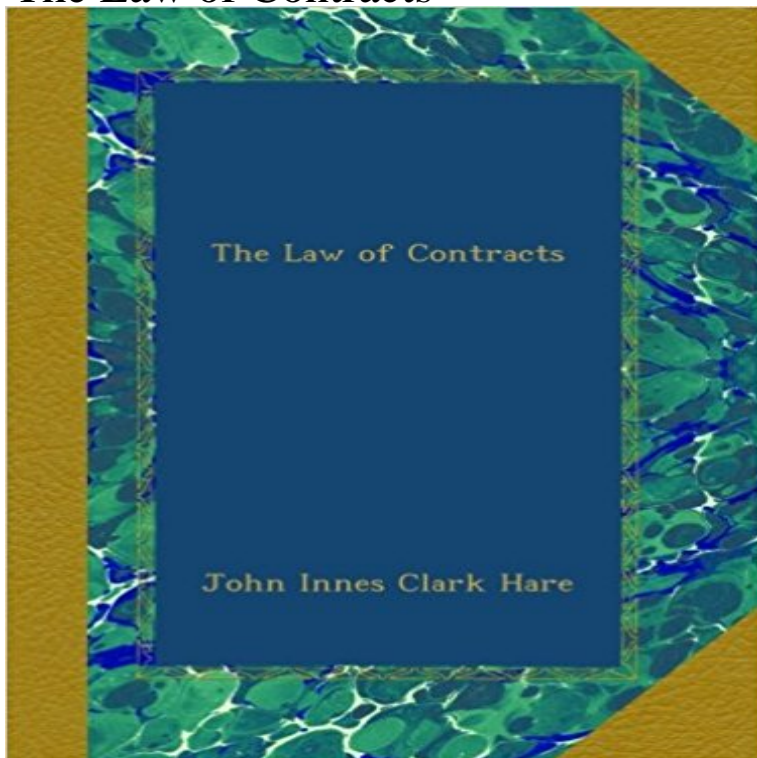


# The Law of Contracts
