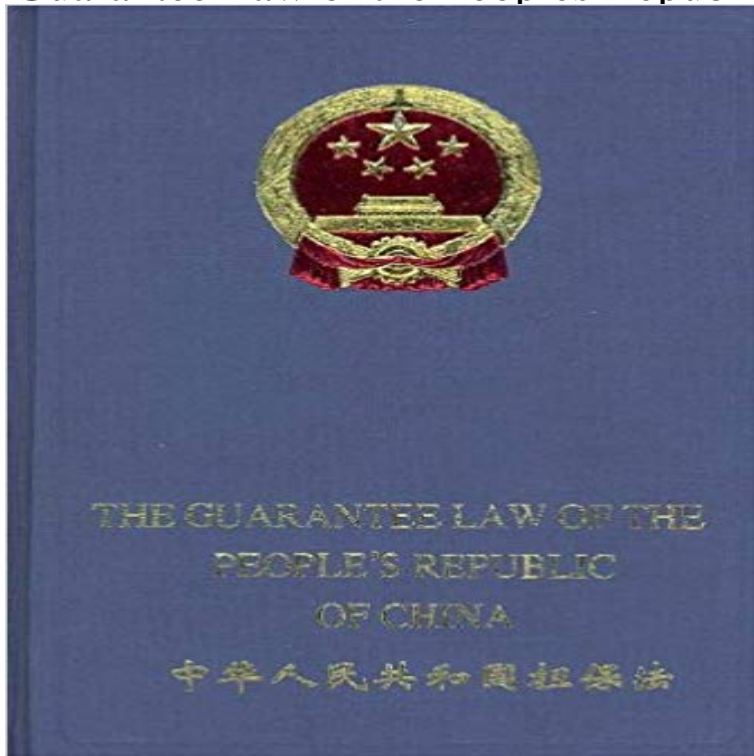


Guarantee Law of the Peoples Republic of China
