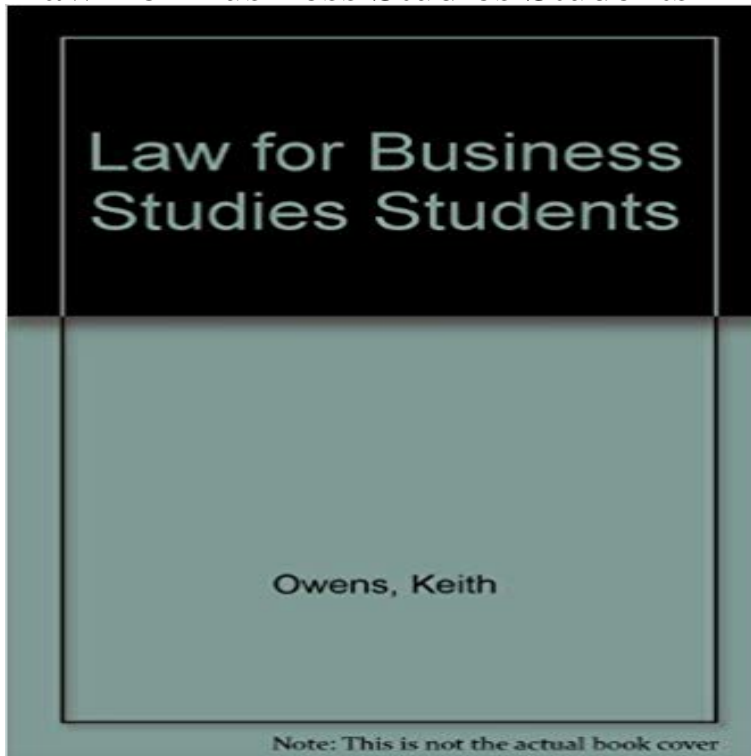


## Law For Business Studies Students
