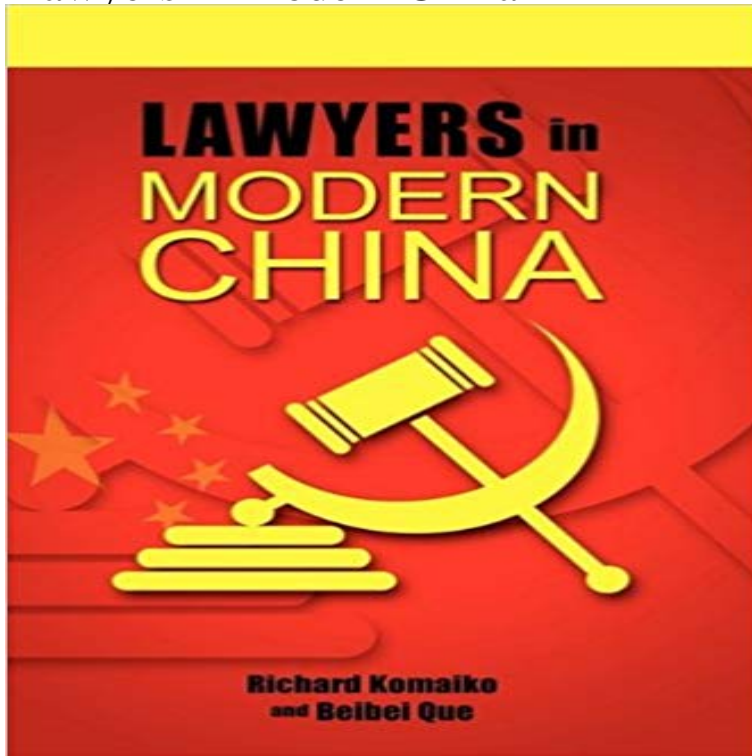


## Lawyers in Modern China
