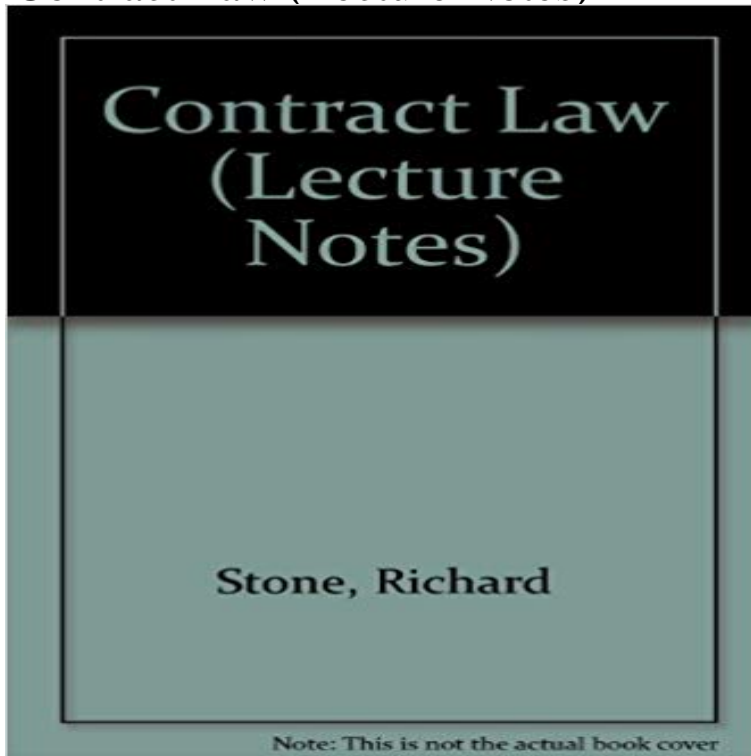


Contract Law (Lecture Notes)
