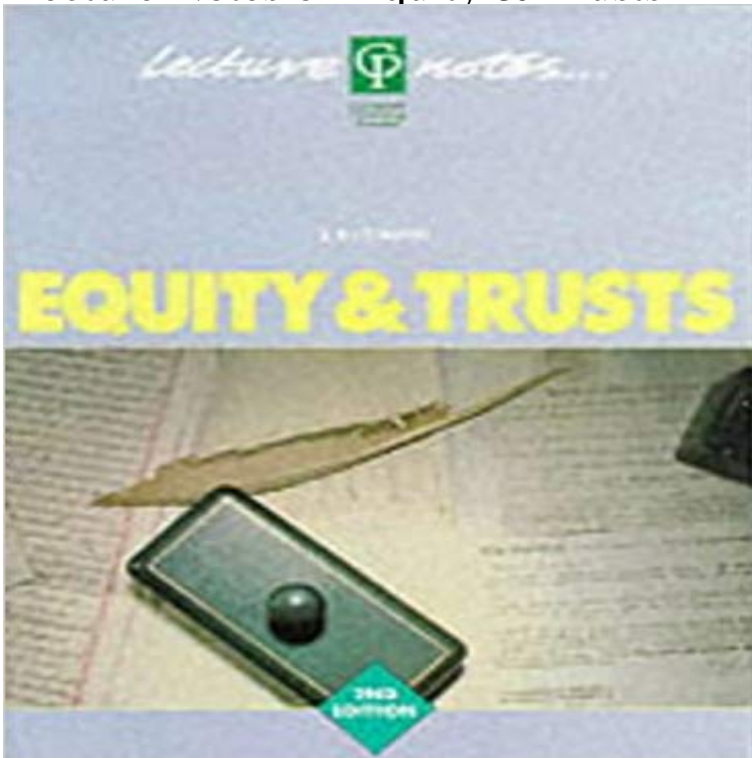


## Lecture Notes on Equity & Trusts
