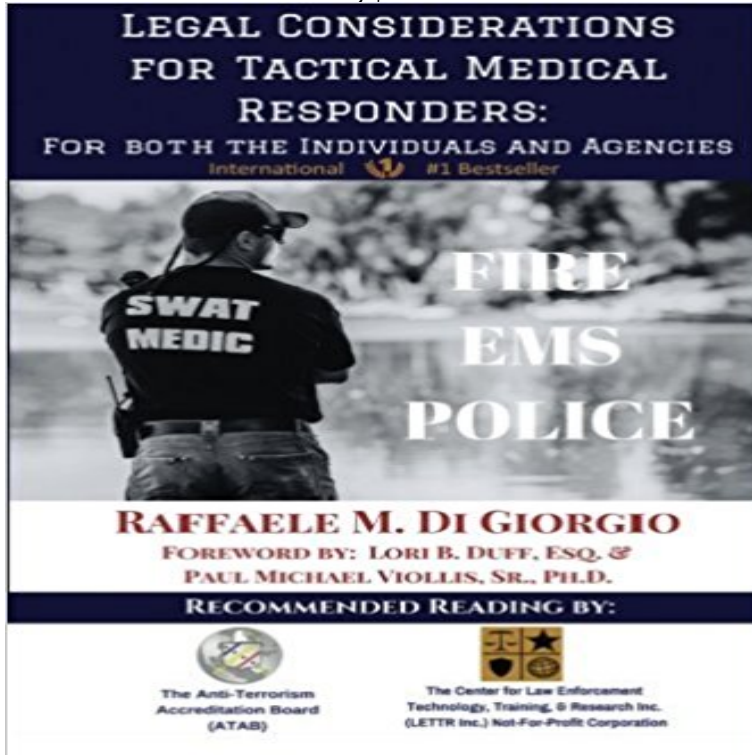


# Legal Considerations for Tactical Medical Responders: For Both Individuals and Agencies
