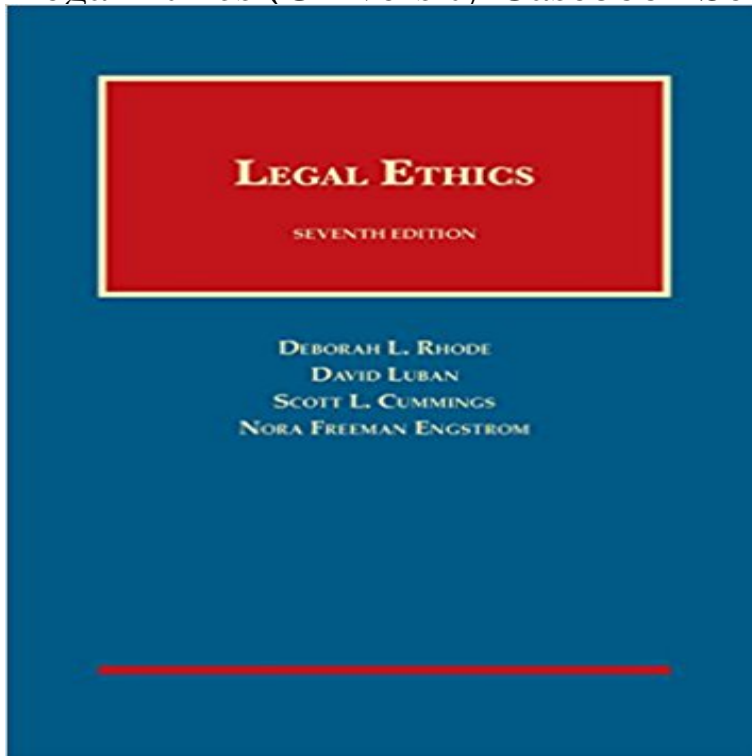


## Legal Ethics (University Casebook Series)

Key changes include expanded coverage of how the lawyer-client relationship begins and ends; important updates to the materials on confidentiality, conflicts of interest, and market regulation; and new research on access to justice and the challenges to contemporary legal education.
