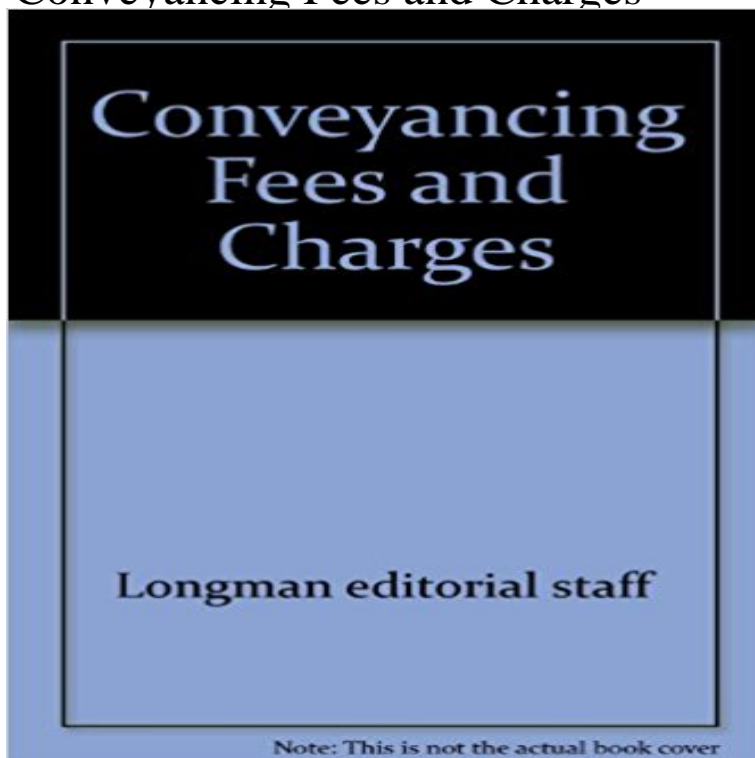


Conveyancing Fees and Charges
