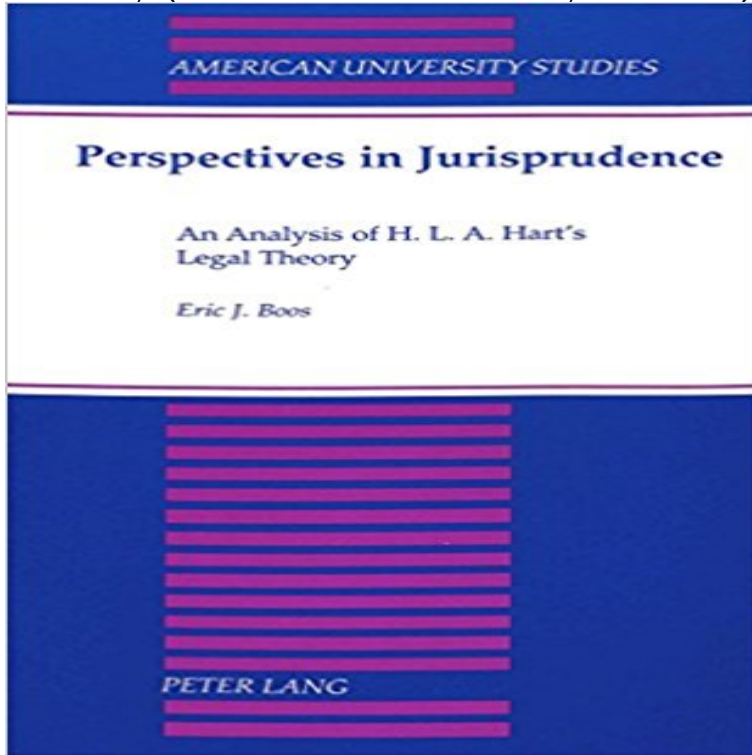


Perspectives in Jurisprudence: An Analysis of H. L. A. Harts Legal Theory (American University Studies)

It provides a detailed examination of Harts efforts to establish a legal framework through primary and secondary rules and an ultimate rule of recognition. It focuses specifically on Harts reliance on the internal perspective as a means of establishing the form of obligation necessary for a legal system. It examines Harts treatment of the relationship between law and morality and Harts mischaracterization of St. Thomas Aquinass natural law theory.
