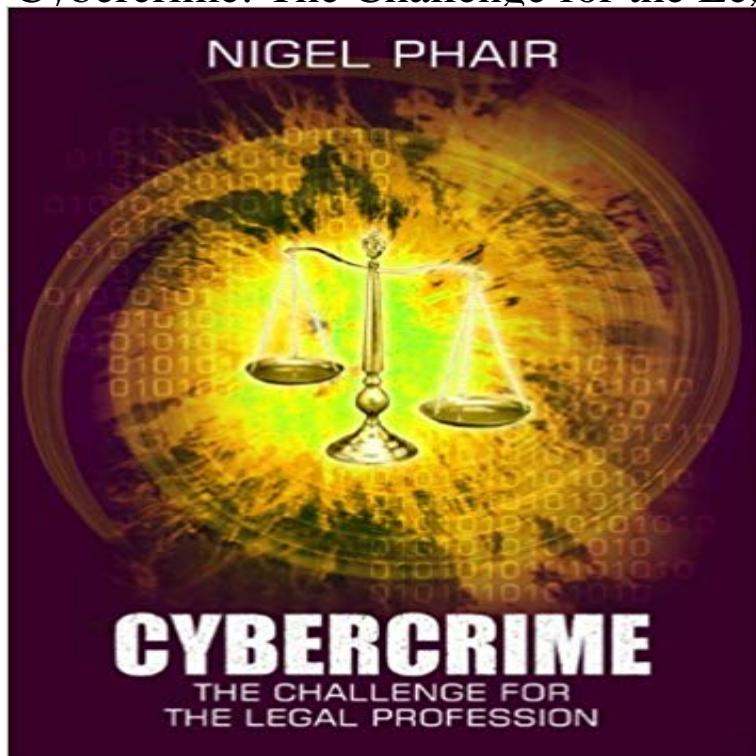


Cybercrime: The Challenge for the Legal Profession
