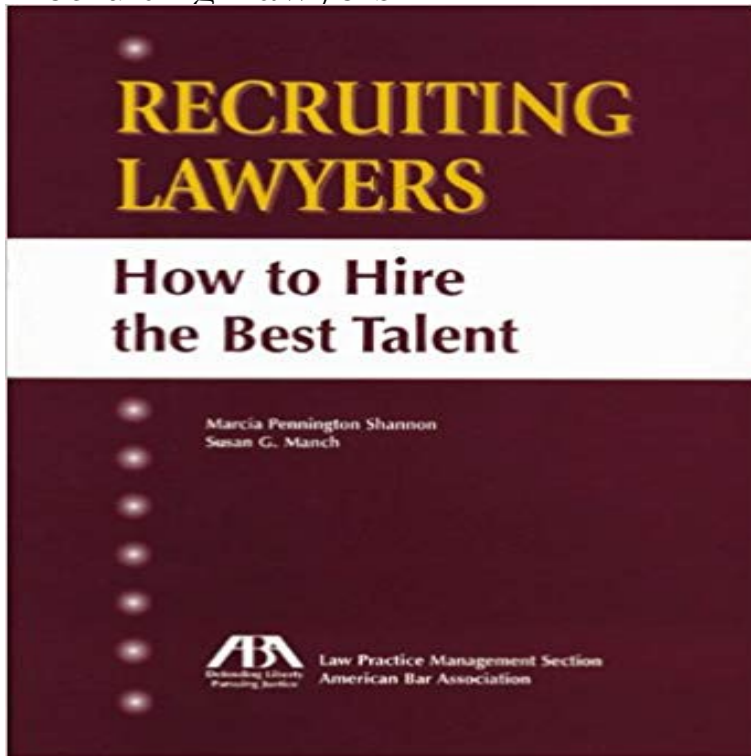


## Recruiting Lawyers
