The contents cover a wide range of risk issues as they arise in legal contexts, ranging from the problems of assessing risks within the criminal justice system to the difficulties that judges encounter in processing risk-laden issues through the courts. This study brings together papers delivered at the WG Hart Legal Workshop of 1995, held at the Institute for Advanced Legal Studies in London.
