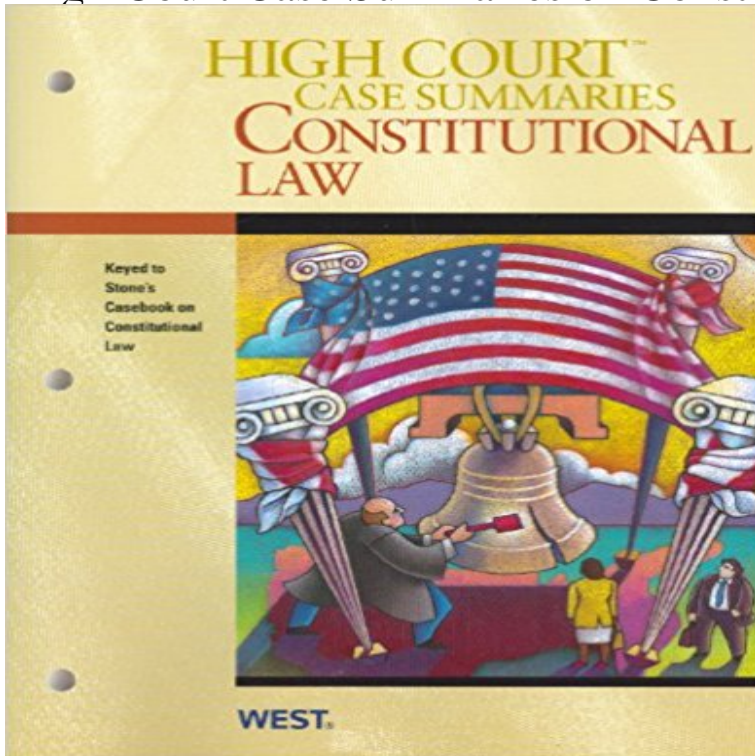


## High Court Case Summaries on Constitutional Law, Keyed to Stone, 6th
