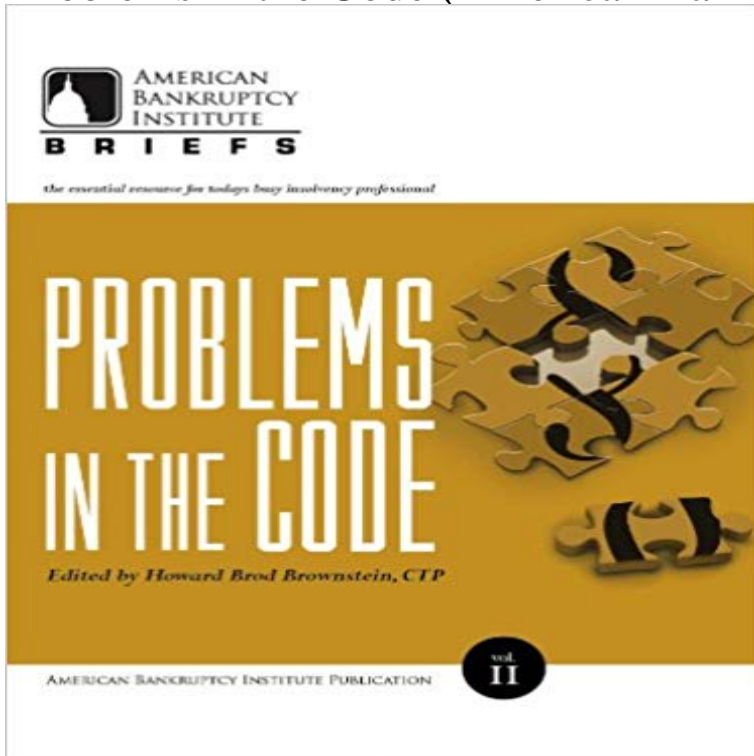


## Problems in the Code (American Bankruptcy Institute Briefs Book 2)

This digital book draws on the work being performed by the ABI Commission to Study the Reform of Chapter 11, launched in 2012 to gather testimony on possible needed changes to the Code enacted in the Bankruptcy Reform Act of 2005. It includes sections on problems regarding Constitutional Law, executory contracts, intellectual property, real estate and environmental issues, and confirmation and post-confirmation issues. A final chapter details the work of the Commission to date and its plans to present its findings to Congress in 2014.
