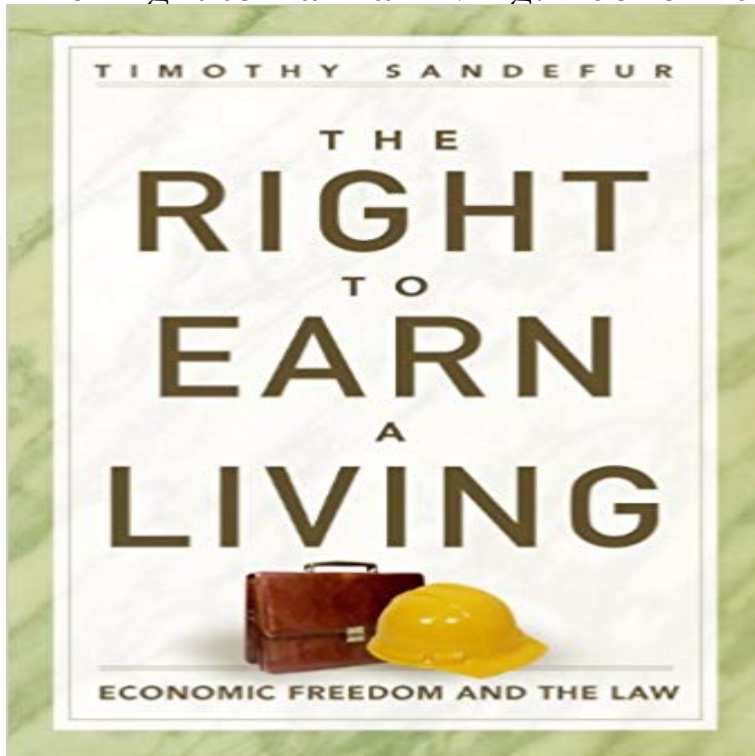


## The Right to Earn a Living: Economic Freedom and the Law
