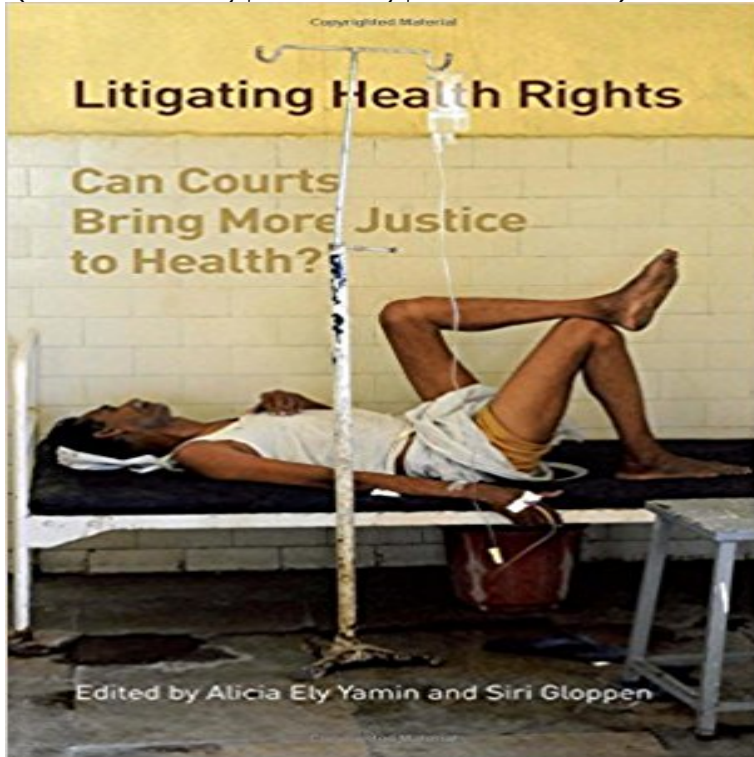


## Litigating Health Rights: Can Courts Bring More Justice to Health? (Human Rights Program Series)
