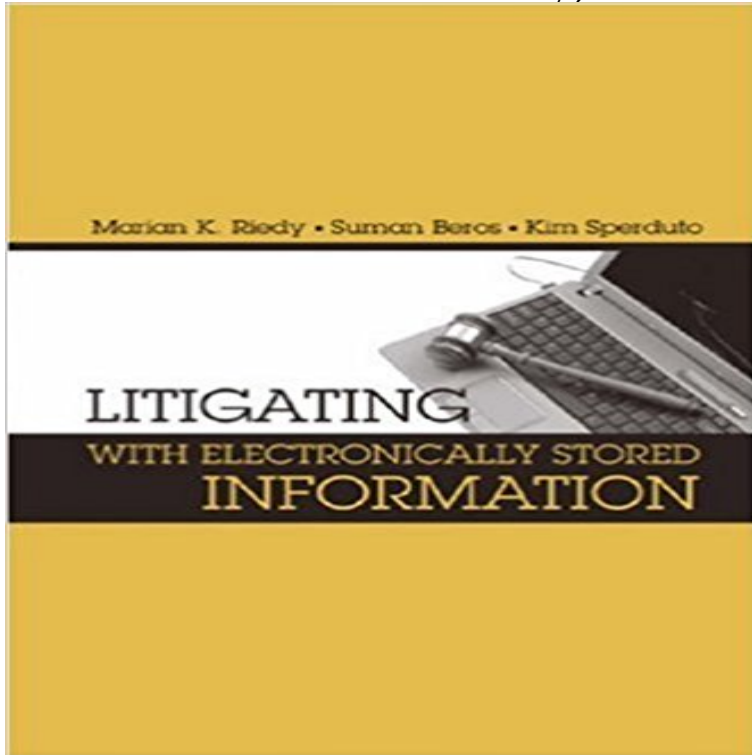


# Litigating With Electronically Stored Information (Artech House Telecommunications Library)
