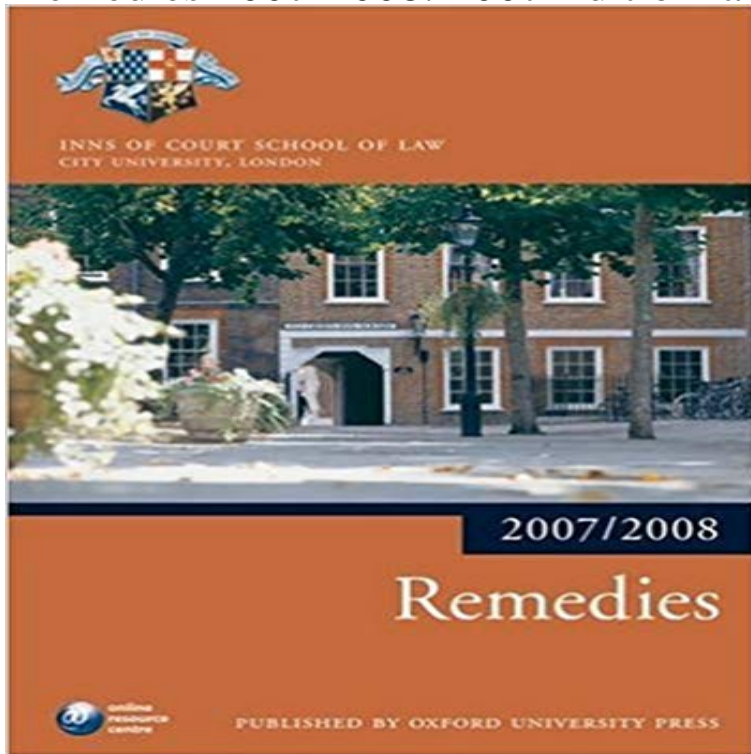


Remedies 2007-2008: 2007 Edition a 2007 ed. (Blackstone Bar Manual)

It then moves on to look at remedies that may be available in various areas of law, including judicial review, real property, trusts, unlawful discrimination, and EC remedies. This provides students with a strong foundation in all areas of a very broad topic. The chapter on the European Convention on Human Rights incorporates all the latest developments in this fast-moving area of law, ensuring that students are kept fully up to date. The last section of the manual sets out some problems which encourage students to apply the relevant law and to practice choosing the remedy that will best serve their clients objective.
