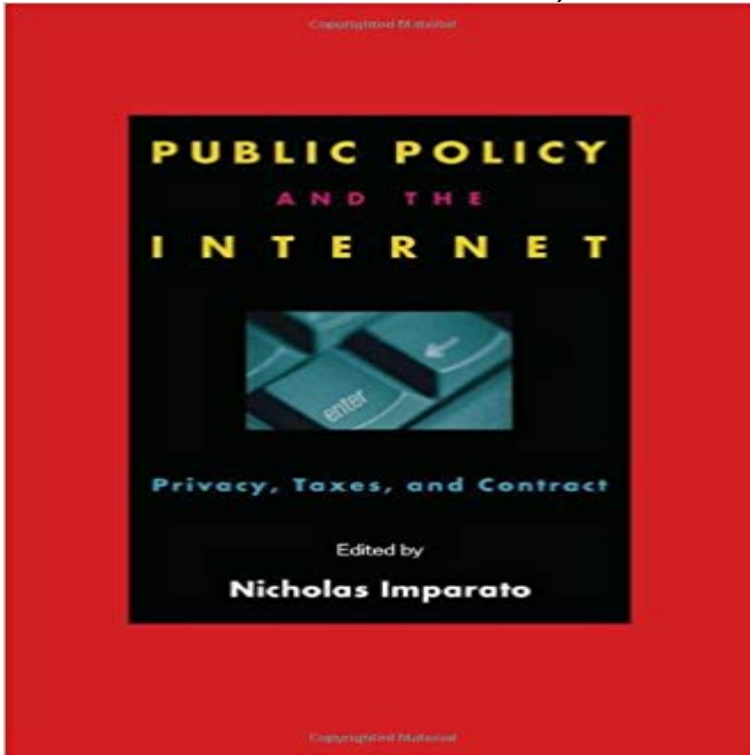


Public Policy and the Internet: Privacy, Taxes, and Contract (Hoover Institution Press Publication)
