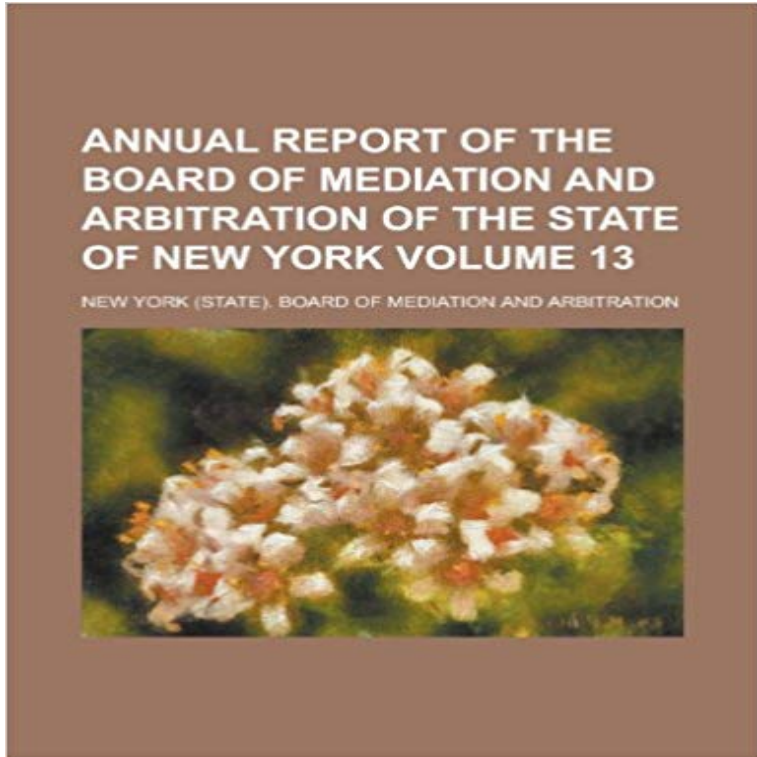


# Annual Report of the Board of Mediation and Arbitration of the State of New York Volume 13

Excerpt: ... with which the machinists on strike were affiliated, had waited upon the employers, intending to present a formal request that he should yield to the demands of the strikers. This committee failed to obtain an interview and reported to the committee in charge of the strike that they should recommend at a meeting of their central body to be held that evening, the calling out of the entire force of employees in the establishment. At the urgent request of Commissioner Johnson, supplemented by the advice of Mr. George H. Warner, business agent of the International Machinists Union, acting in an advisory capacity to the strike committee, and several members of the strike committee, it was finally decided that action looking to the calling out of all of the employees should be deferred until after the pending conference to be held that morning, which, if successful in effecting a settlement, would obviate the necessity of further action in the direction of a general strike. Work was resumed on August 29th, upon the terms agreed on and has since continued without interruption. There have, however, been complaints filed with the Board of a failure on the part of the employer to adhere strictly to the terms of the settlement, and the intervention of the Board has on two or three occasions been asked. In response, the Board, through Commissioners Johnson and Webster has endeavored to effect a more satisfactory condition in the premises as indicated by the following correspondence on the subject with the employer and with the representative of the disaffected employees: STATE OF NEW YORK, Board Of Mediation And Arbitration, Albany, December 20, 1898.
