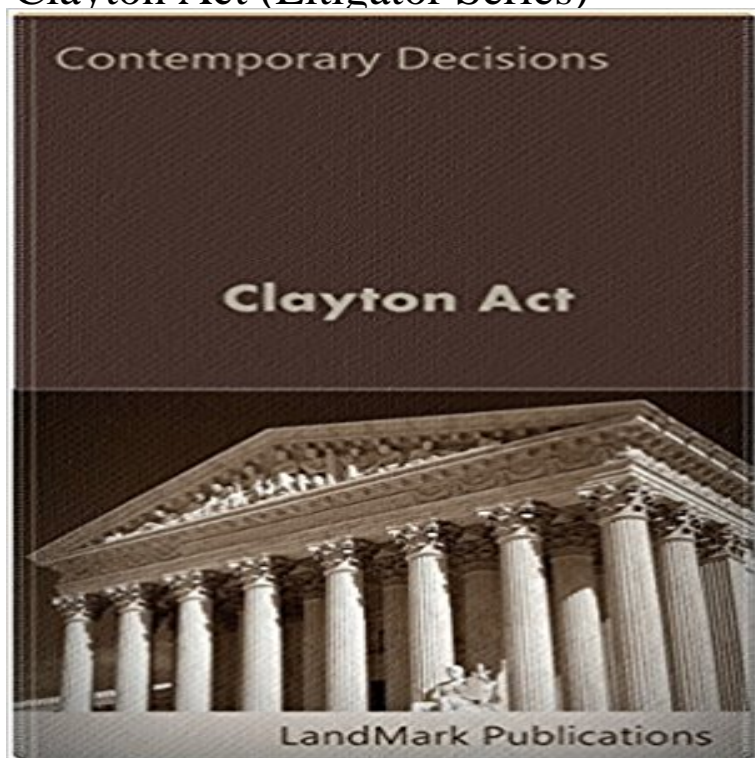


Clayton Act (Litigator Series)

Section 7 of the Clayton Act prohibits mergers where in any line of commerce... the effect of such acquisition may be substantially to lessen competition, or to tend to create a monopoly. 15 U.S.C. 18. As its language suggests, Section 7 deals in probabilities, not certainties. *Brown Shoe Co. v. United States*, 370 U.S. 294, 323, 82 S.Ct. 1502, 8 L.Ed.2d 510 (1962). *ProMedica Health System, Inc. v. FTC*, 749 F.3d 559 (6th Cir. 2014). Merger enforcement, like other areas of antitrust, is directed at market power. *FTC v. H.J. Heinz Co.*, 246 F.3d 708, 713 (D.C.Cir.2001) (quoting Lawrence A. Sullivan & Warren S. Grimes, *The Law of Antitrust* 9.1 at 511 (2000)). Market power is itself a term of art that the Department of Justice Horizontal Merger Guidelines [. . .] define as the power of one or more firms to raise price, reduce output, diminish innovation, or otherwise harm consumers as a result of diminished competitive constraints or incentives.
