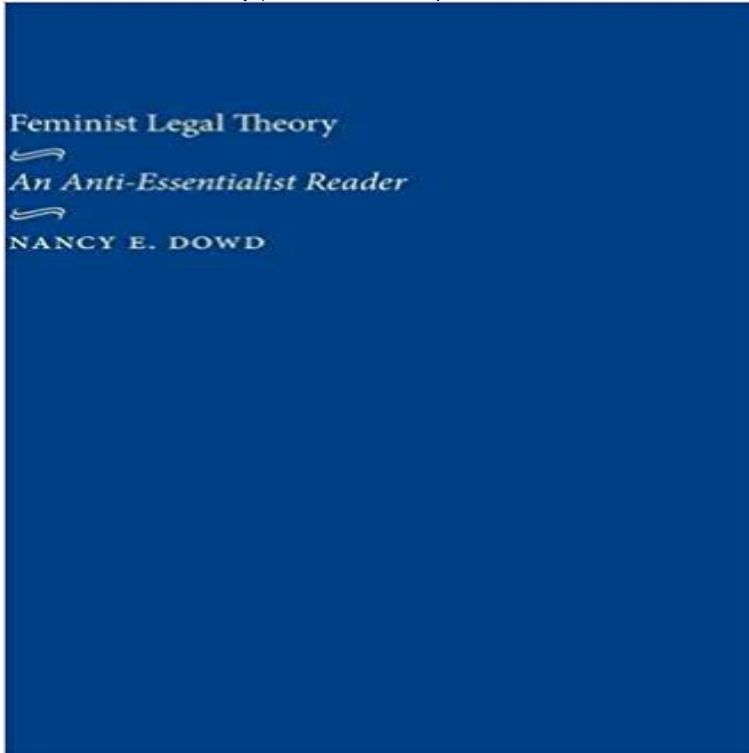


Feminist Legal Theory: An Anti-Essentialist Reader
