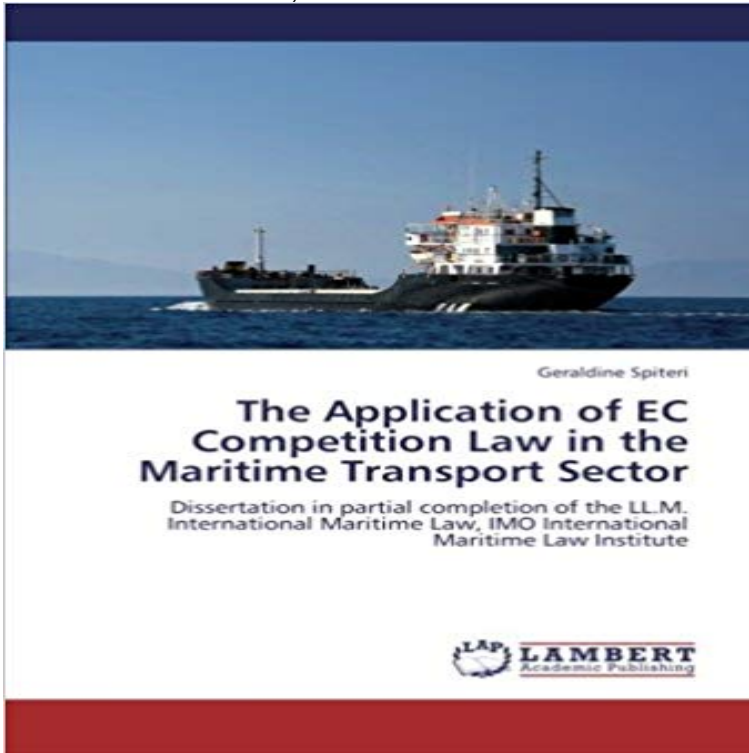

This book explores the possible changes in the way that liner shipping takes place, in consequence of the removal of the EU Block Exemption Regulation on Liner Conferences. It is expected that some changes would have to be made, in particular concerning collusive practices that might no longer be exempted, and would therefore fall under the EU competition law rules as found in the Treaty.
