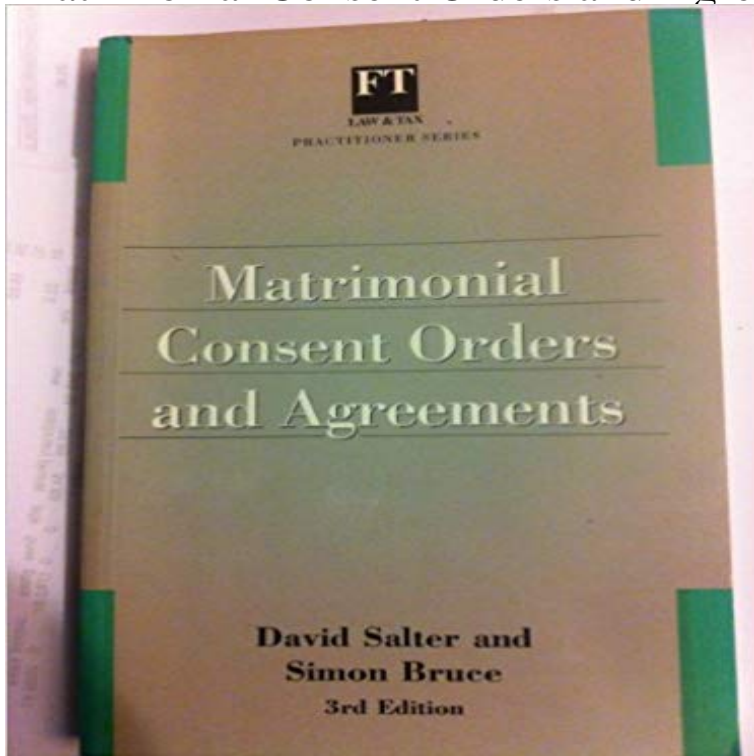


Matrimonial Consent Orders and Agreements (Practitioner Series)
