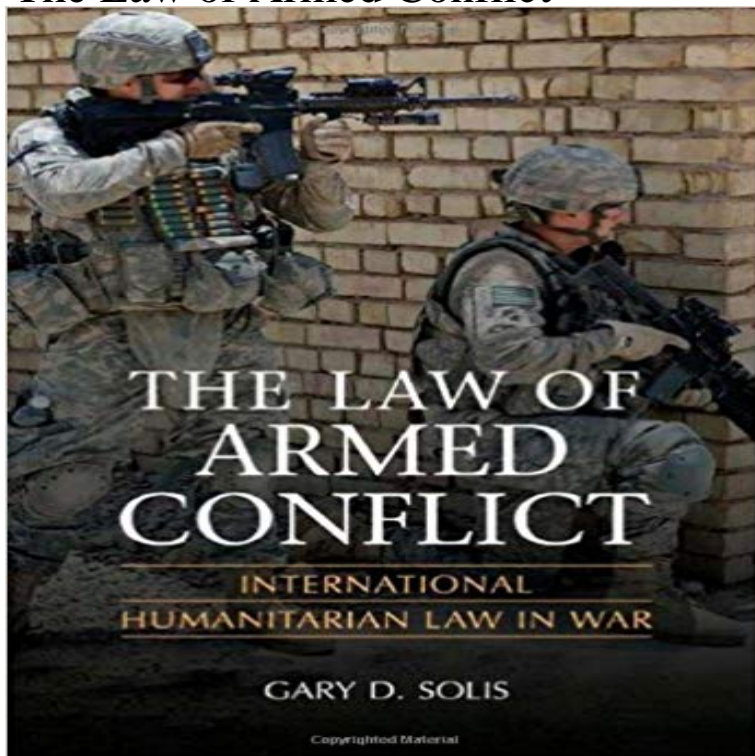


## The Law of Armed Conflict
