A steadily increasing appreciation of the value of wetlands and recognition of the factors leading to their loss have spurred the federal government to introduce a series of programs to regulate and manage wetlands. The benefits of these wetland protection programs accrue to the general public, while the largest share of protection costs are borne by private landowners.
