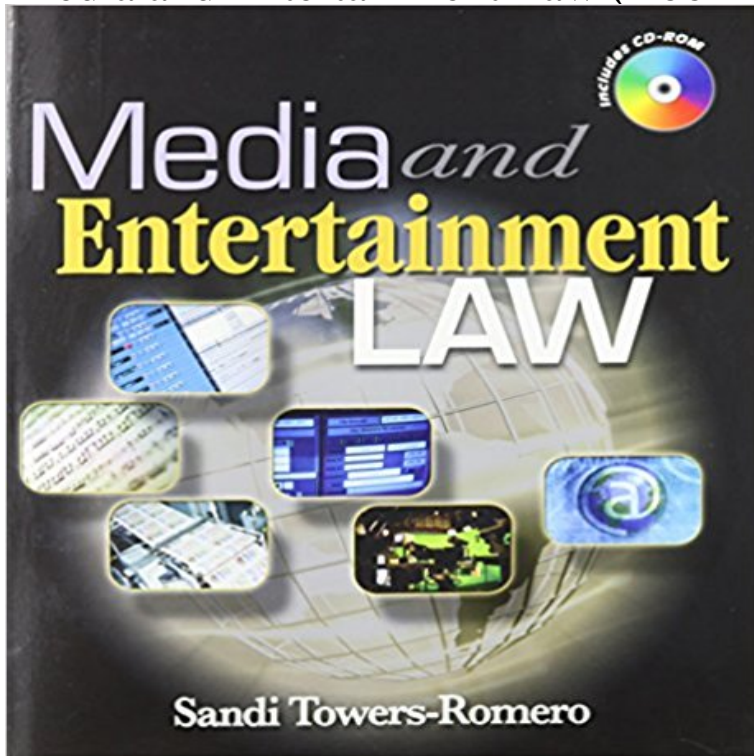


## Media and Entertainment Law (Book Only)
