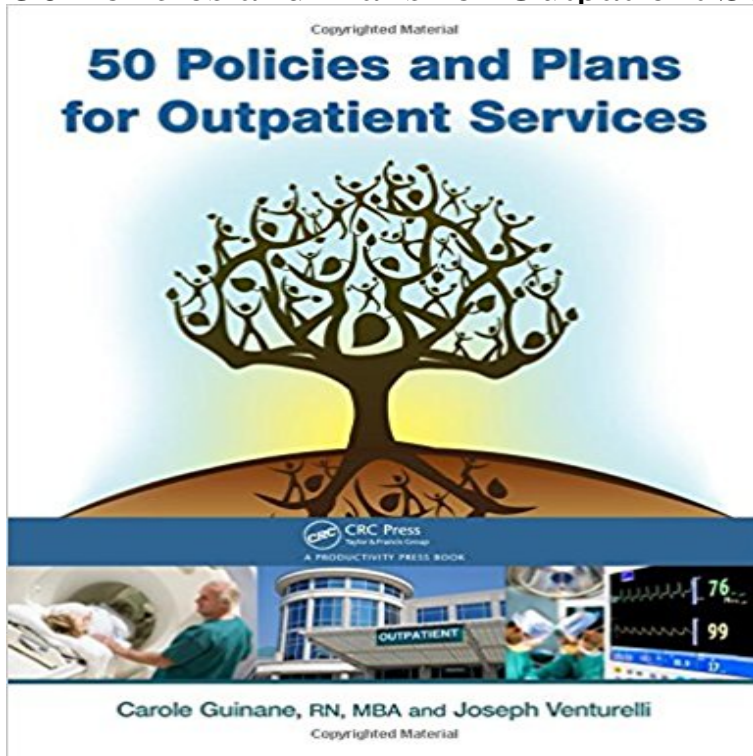


## 50 Policies and Plans for Outpatient Services
