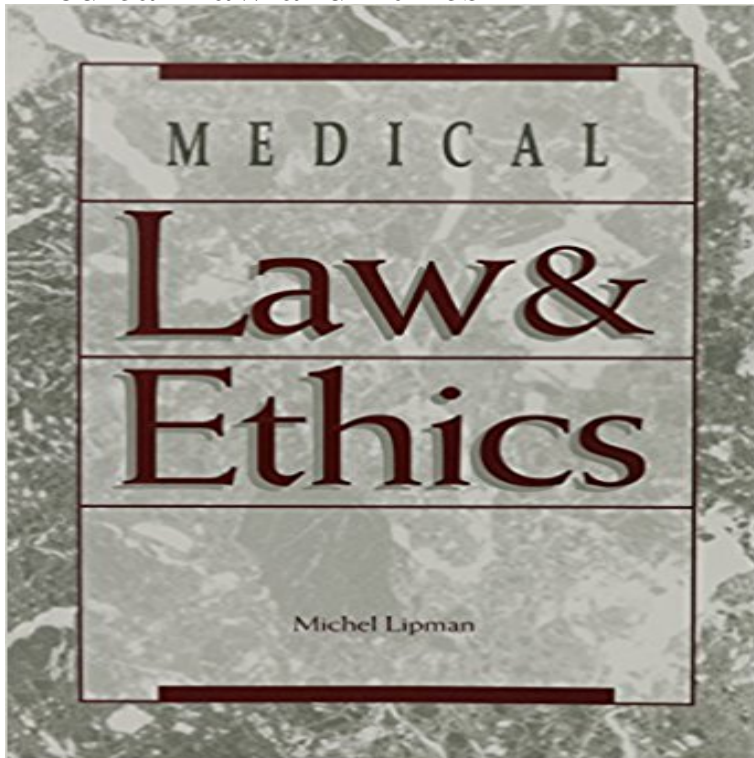


## Medical Law and Ethics
