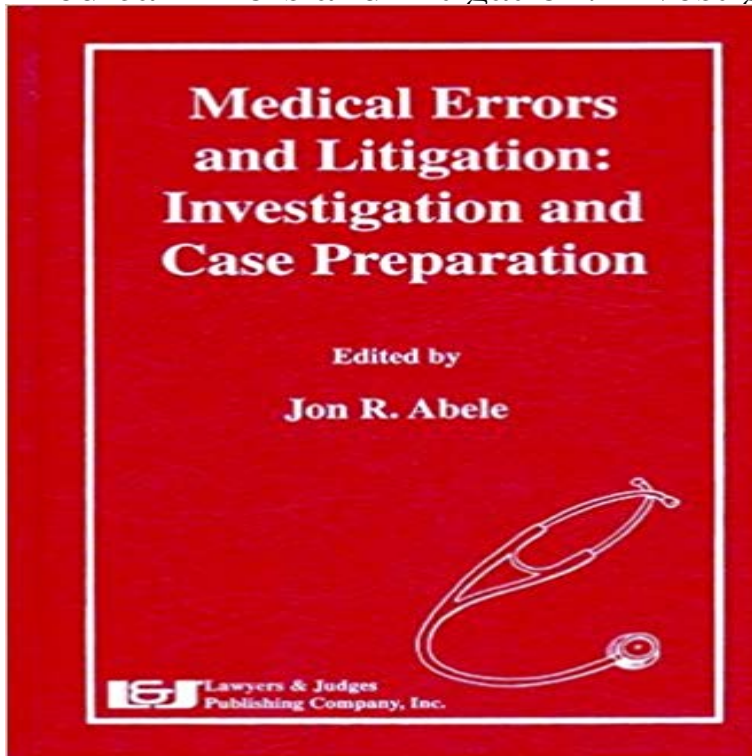


Medical Errors and Litigation: Investigation and Case Preparation
