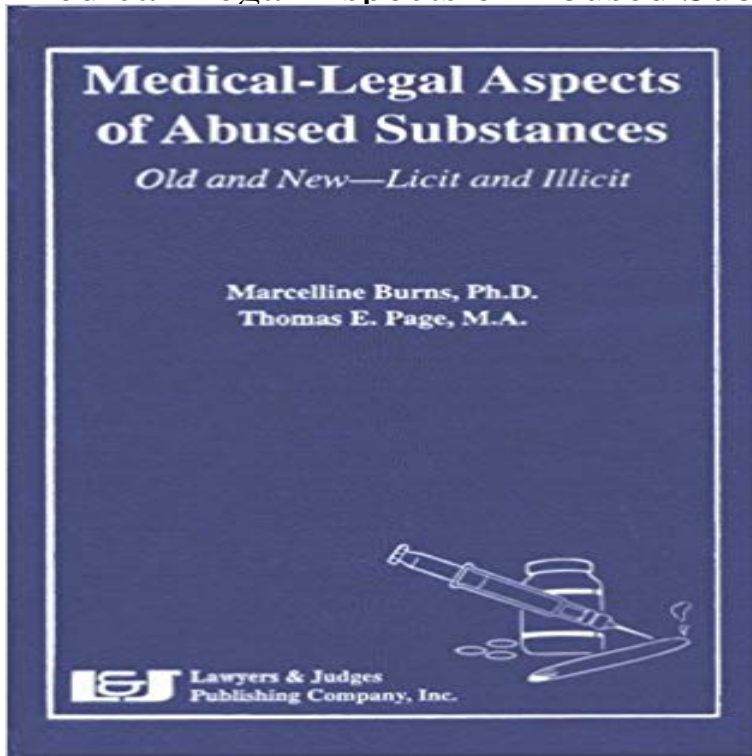


## Medical-Legal Aspects of Abused Substances: Old & New Licit & Illicit
