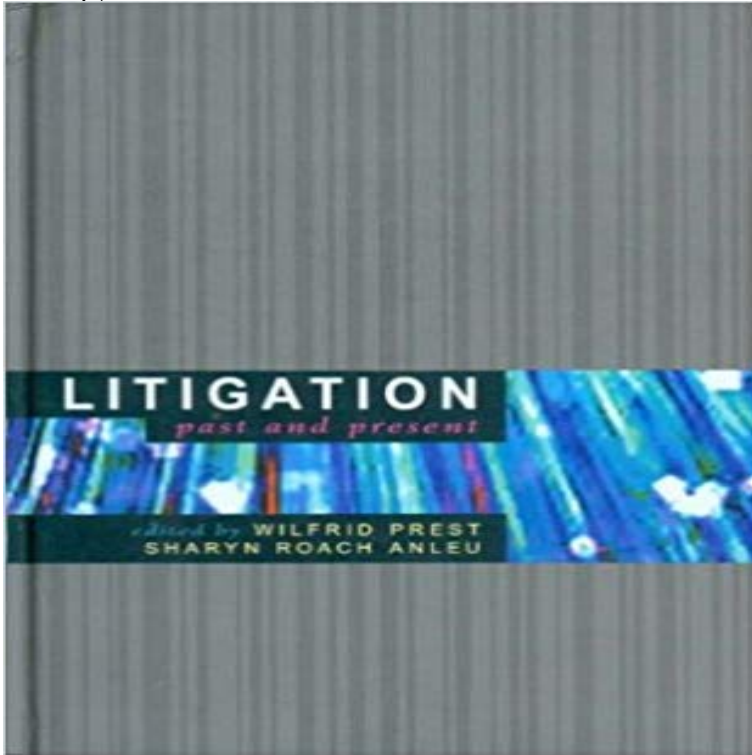


## Litigation: Past and Present
