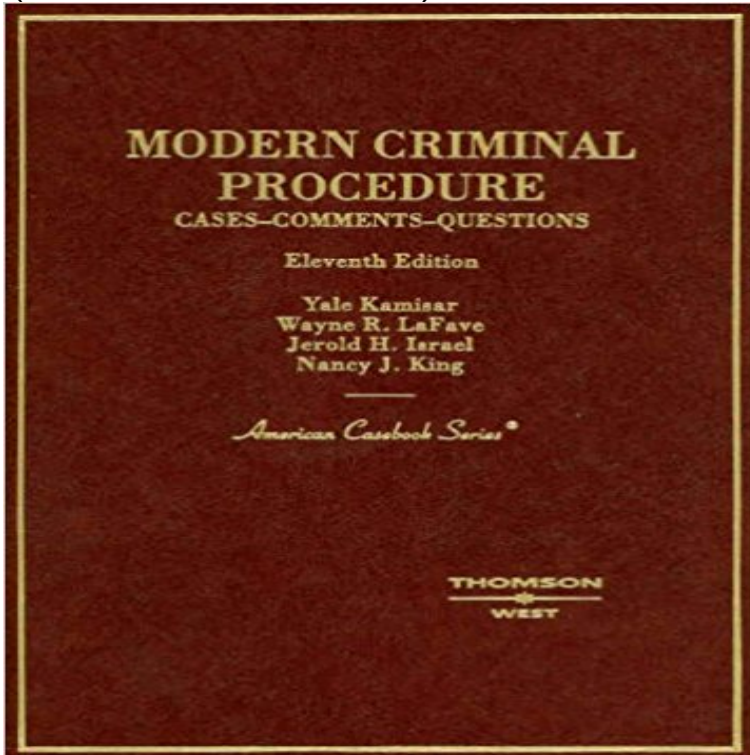


Modern Criminal Procedure: Cases, Comments, and Questions (American Casebook)
