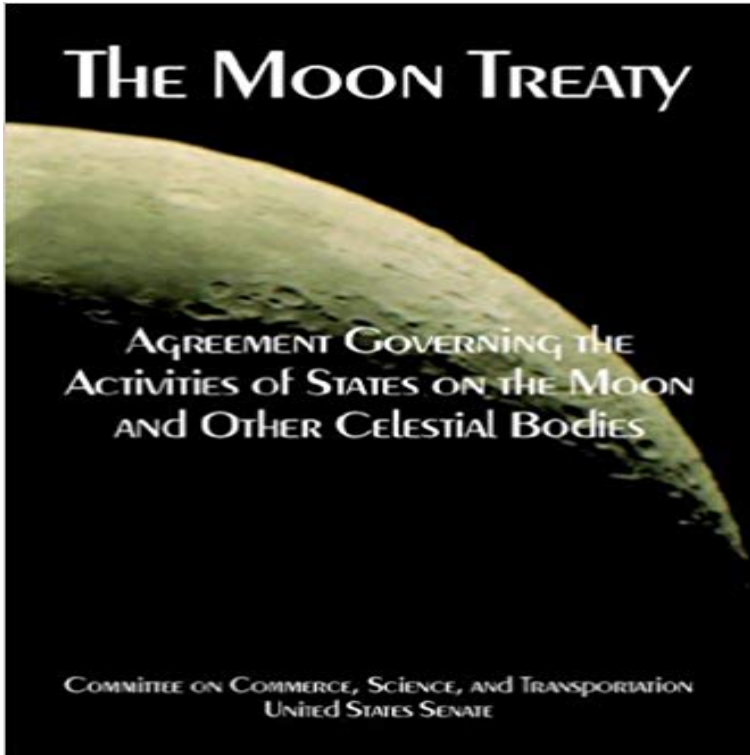


The Moon Treaty: Agreement Governing the Activities of States on the Moon and Other Celestial Bodies
