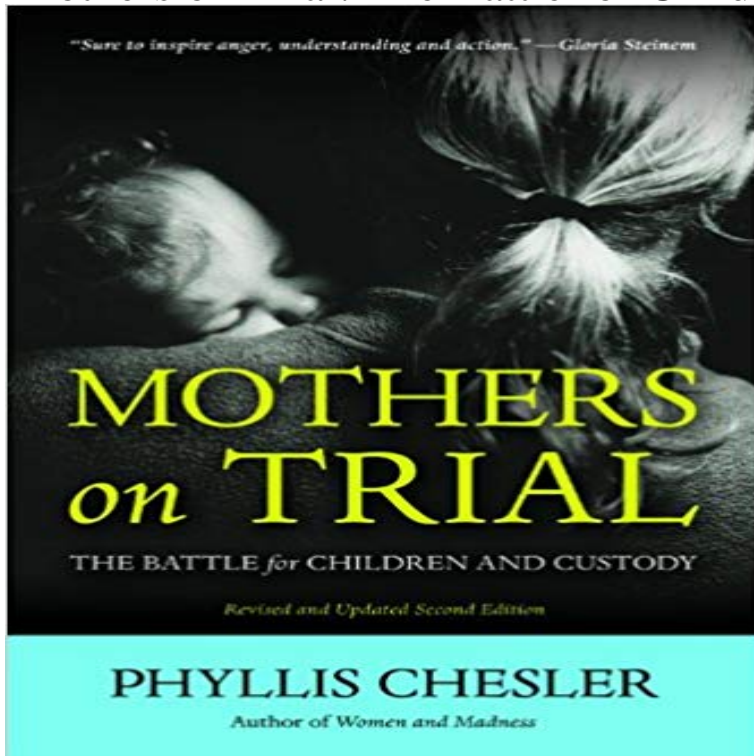


## Mothers on Trial: The Battle for Children and Custody
