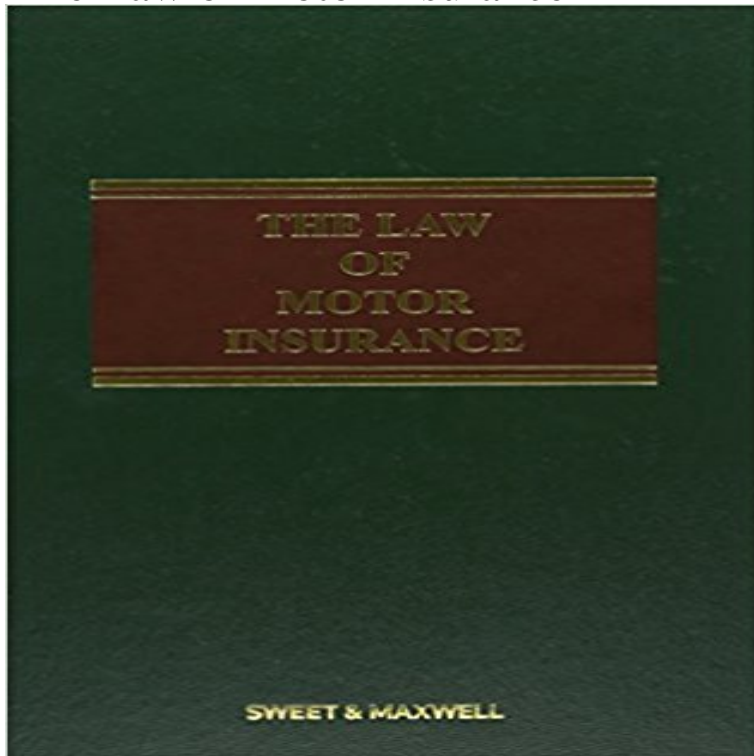


# The Law of Motor Insurance
