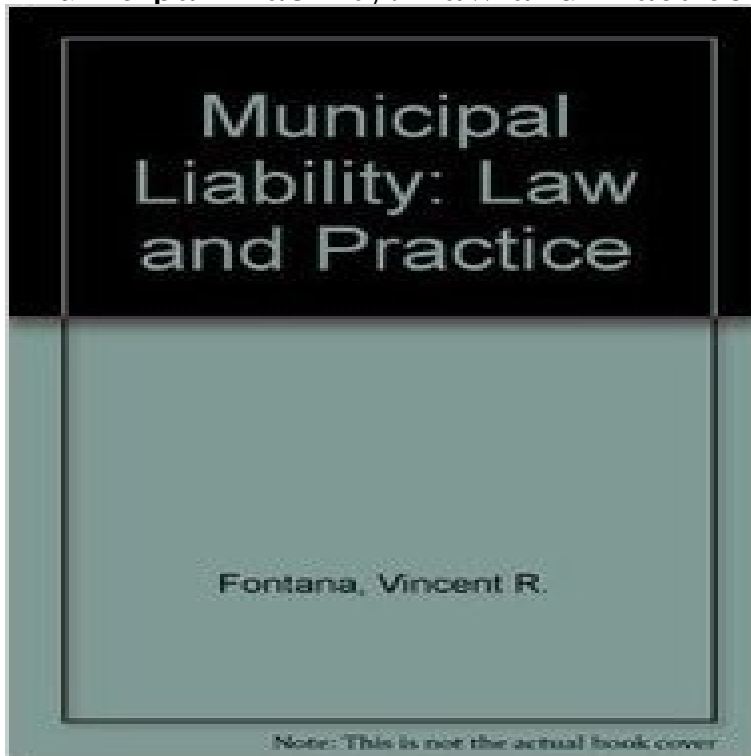


Municipal Liability: Law and Practice

the failure to issue a building permit or properly inspect a facility before issuing a certificate of occupancy. Police Misconduct: Topics include liability for police officers, supervisors and municipalities; how to show illegal searches, excessive use of force and other violations; malicious prosecution, prisoners rights and freedoms; exhausting state remedies; and more.
