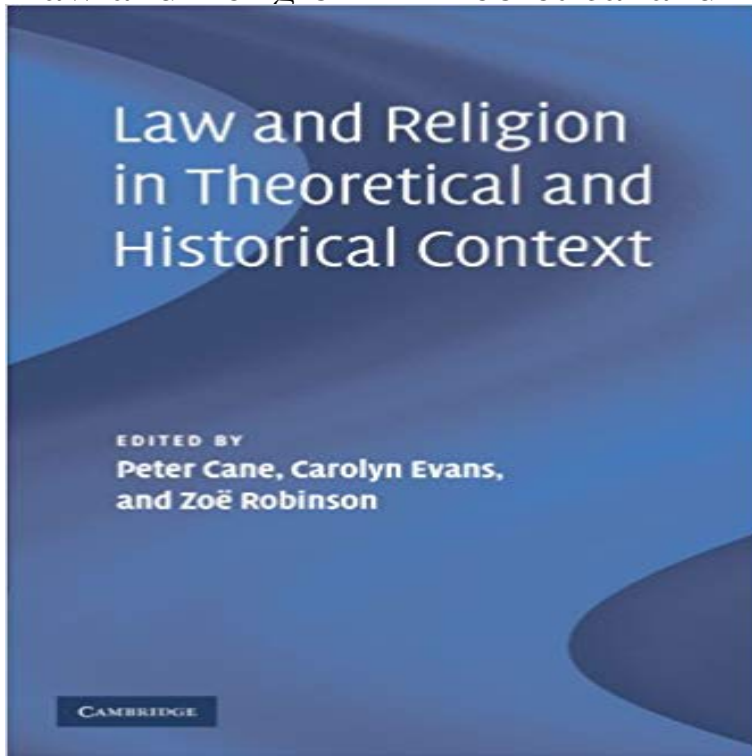


Law and Religion in Theoretical and Historical Context
