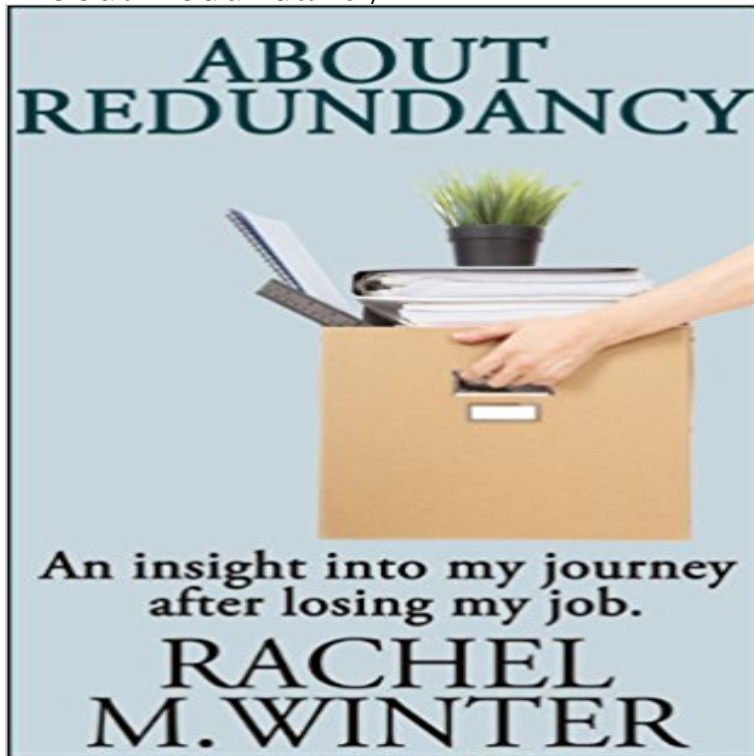


About Redundancy
