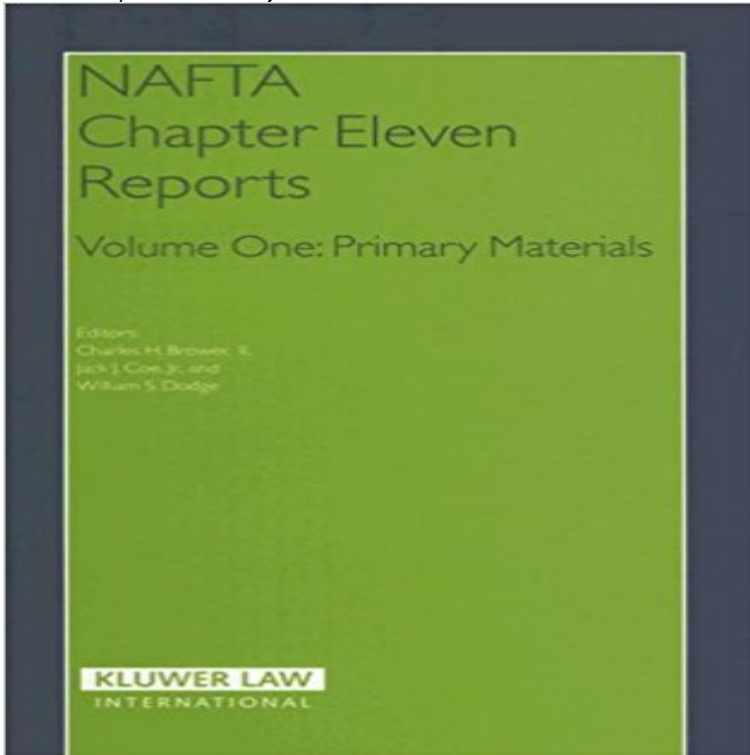


Nafta Chapter Eleven Reports: Volume I, Basic Text (NAFTA Law and Policy Series)
