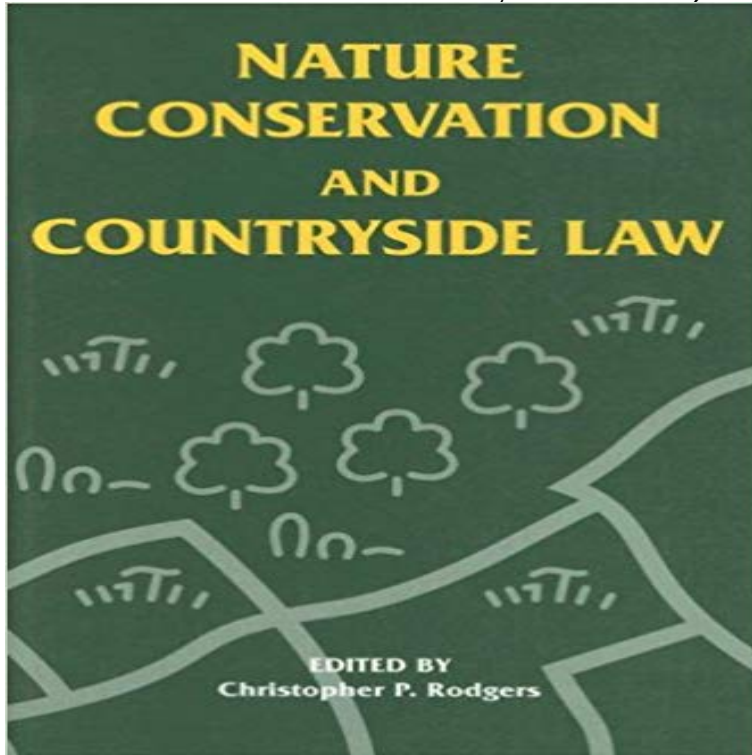


## Nature Conservation and Countryside Law (University of Wales Press - Environment and Countryside Law)
