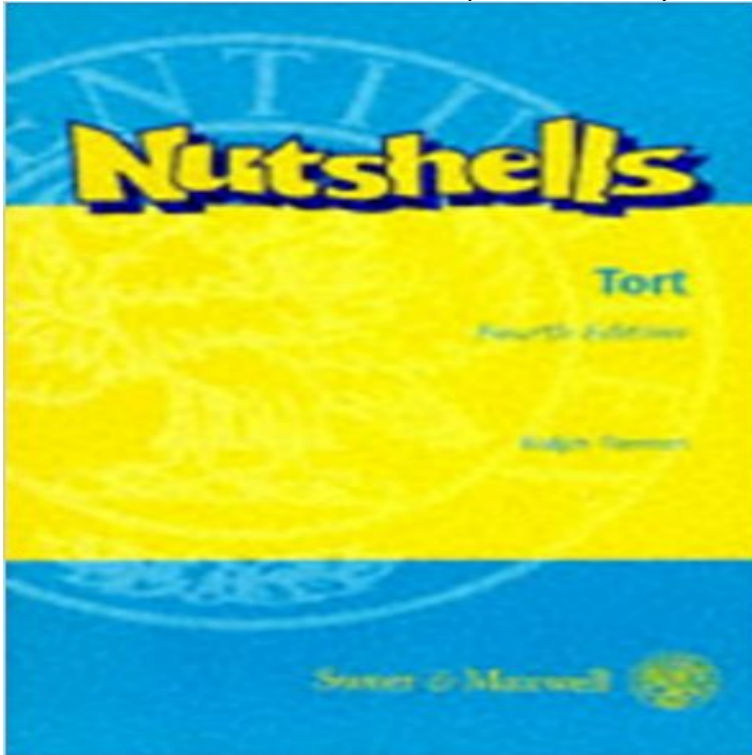


Tort Law in a Nutshell (Nutshells)
