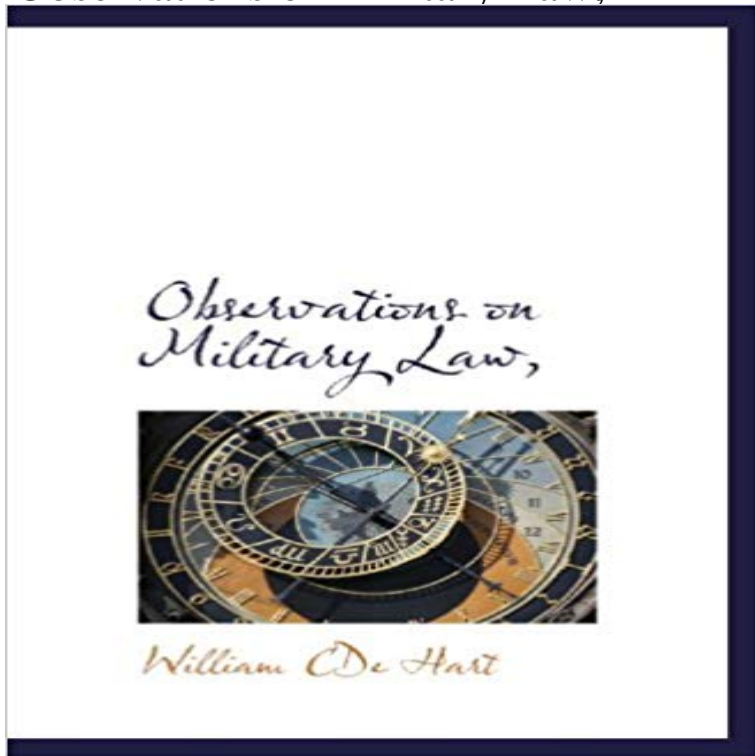


Observations on Military Law,
