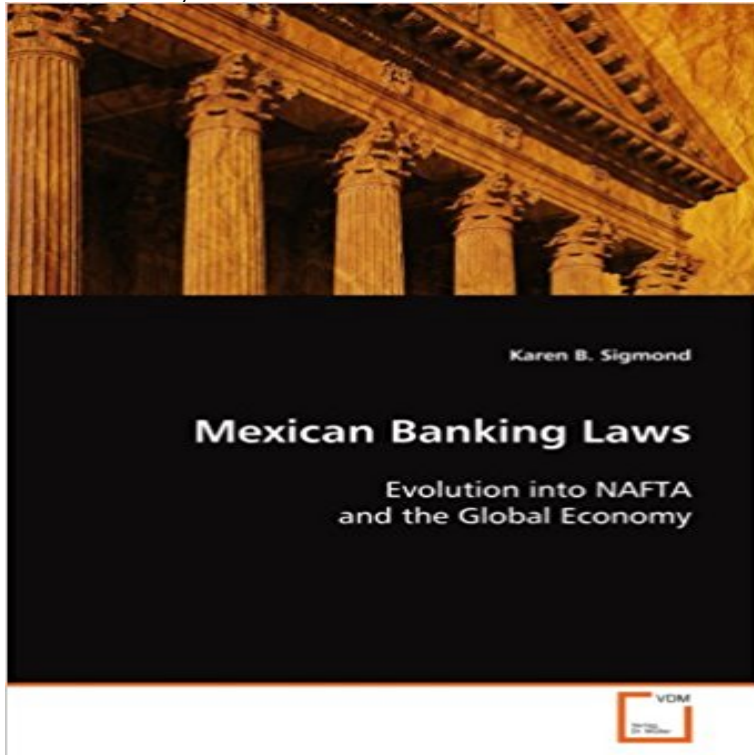


Mexican Banking Laws: Evolution into NAFTA and the Global Economy
