It furthermore provides an analysis at once fascinating and critical of a field of law, the very dynamics of which contribute to offer major challenges to all those involved in it and with it, whether they are policy makers, practitioners, enforcers or indeed consumers - general or in-house counsel, as well as the final consumers of the products and services offered by their firms. Any attempt to capture and systematically analyze these dynamics - the shifting sands and troubled waters - the remarkable journey towards convergence - to borrow from the titles of just two of the contributions to this Liber is a complex intellectual endeavour and practical challenge in its own right.
