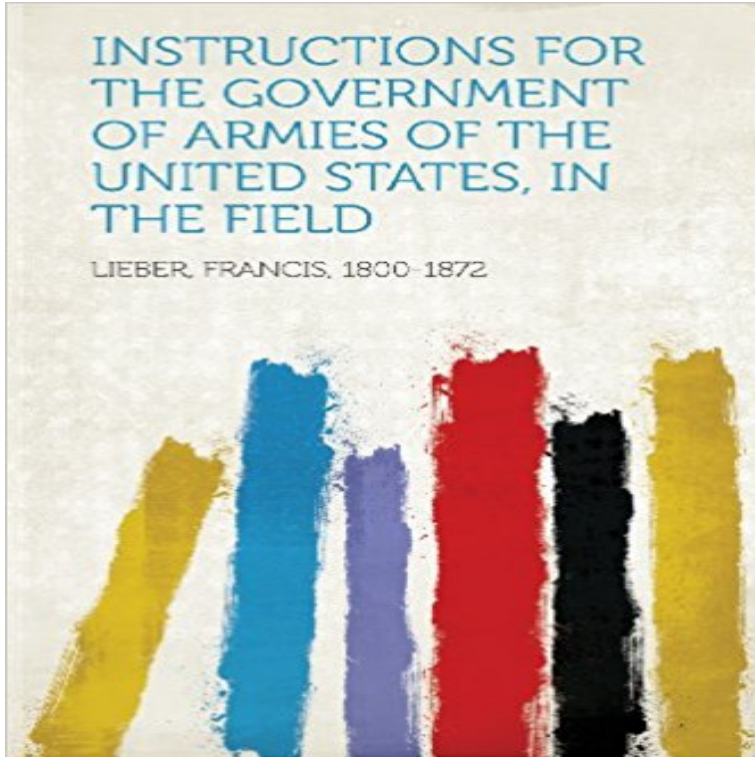


# Instructions for the Government of Armies of the United States, in the Field
